JPNIC not AkhileshYadav's private property, it belongs to public: UP Deputy CM

LUCKNOW, JULY 6 --/ Uttar Pradesh Deputy Chief Minister Brajesh Pathak on Saturday hit out at Samajwadi Party president AkhileshYadav over his statement on Jai Prakash Narayan International Centre (JPNIC) in Lucknow, saying that it is a public property and not Yadav's personal asset. Earlier in the day, Yadav had accused the BJP of a well-planned strategy to first end the JPNIC society through a cabinet decision and then prepare to sell it. In an official statement, Pathak said, "You (Yadav) had made it a den of corruption, whereas it was a centre built with the hard-earned money of the public ... AkhileshYadav considers the people of Uttar Pradesh to have a short memory, but the people are now aware and will not be misled."

"Our government passed a proposal from the cabinet and handed it over to the Lucknow Development Authority, so that this property is used in the service of the common people. It was not your personal property," he added. The Uttar Pradesh Cabinet had on Thursday approved the proposal to dissolve the society formed for the Jai Prakash Narayan International Centre project. The decision also said that its reins would be handed over to the Lucknow Development Authority. Pathak alleged that the Samajwadi Party government from 2012 to 2017 institutionally promoted corruption, nepotism, mining scams and misuse of government resources. "During that tenure, nepotism and criminals were prevalent everywhere, to which the public has responded by ousting them from power twice," the deputy chief minister said. Regarding the Gomti River Front, Pathak said that this project was worth a few hundred crores, but thousands of crores were spent. (PTI)

## Interpretation of Constitution has to be pragmatic: CJI

MUMBAI, JULY 6 --/ Chief Justice of India BhushanRamkrishnaGavai has said the interpretation of law or the Constitution has to be "pragmatic" and in a way that suits the needs of society. Speaking at a felicitation organised for him by the Bombay High Court here on Saturday, he also said he recently received complaints about the rude behaviour of "some of the colleagues", and urged judges to protect the institution's reputation. Citing a past Supreme Court judgement, CJI Gavai said any law or the Constitution has to be interpreted in the context of "problems faced by the present generation."

"The interpretation has to be pragmatic. It has to be one that suits the needs of society," he added.

Judges are expected to work as per their conscience, the oath of office and law, but "should never be perturbed once

the matter is decided," he said. A judge should cut off his mind from the matter and forget what happens to it thereafter, he said. Talking about the appointment of judges, the CJI asserted that "at no cost the independence of judiciary shall be compromised". While making appointments either to the Supreme Court or high courts, the collegium ensures merit is maintained while there is diversity and inclusiveness, he said. CJI Gavai complimented the Bombay High Court - where he once practised as a lawyer and served as a judge - for its work, and said he feels proud when people appreciate its judgements.

He also said that lately he has been "receiving a lot of complaints about the rude behaviour of some of the colleagues."

"Being a judge is not a 10 to 5 job, it's an opportunity

to serve the society. It is an opportunity to serve the nation," he stressed, and urged the judges to be "true to their oath and commitment." "Please do not do anything which brings disrepute to this august institution, whose reputation has been so laboriously built by the devotion and dedication of generations of lawyers and generations of judges," he said.

Speaking at another felicitation ceremony later on Saturday evening, the CJI said the Constitution works for every last citizen of the country, be it a judge, lawyer, an executive or a parliamentarian. "Let us dedicate our lives to the eradication of all differences, let us give it ourselves to upholding constitutional values, let us give it ourselves towards the fulfilment of our constitutional promises," he added. ## Consent of 10 neighbours required to keep pet dog at home in Surat now

SURAT, JULY 6 --/ A no objection certificate (NOC) from at least 10 neighbours will now be required if residents of a housing society want to keep a pet dog at their home in Surat city of Gujarat, civic officials said on Friday. In case of a multi-storey apartment building, the pet owner must submit an NOC issued by the chairperson and secretary of the residential building, said officials of the Surat Municipal Corporation (SMC). In view of some recent incidents, including a toddler's death in Ahmedabad following a pet canine's attack in May, the SMC has started issuing notices to dog owners, asking them to obtain a licence from the civic body.

So far, nearly 1,000 pet dog owners as well as residential societies have been served notices by the SMC and nearly 300 persons have already applied for obtaining licences, said SMC Market Superintendent Digvijay Ram. "We have started this exercise in the wake of an incident in Ahmedabad where a toddler was mauled to death by a pet Rottweiler dog after it broke free from its owner's control. In Surat also, police have

received complaints against dog owners and FIRs have been also lodged," Ram stated.

"To address this issue, we have made it mandatory for people living in the city to obtain a licence from the SMC to keep a dog at home. They need to fill up a form and submit it to us with required documents such as the dog's vaccination certificate and Aadhaar card of the owner with address proof," said the officer. If the pet owner lives in a housing society, row house scheme, street or 'mohalla' (locality), he will be required to obtain an NOC from at least 10 of his neighbouring residents to prove they have no objection to the person keeping a canine at home, he maintained. In case of a multi-storey apartment building, the pet owner must submit an NOC issued by the chairman and secretary of the residential building, Ram insisted. "The pet owners are required to submit the form and supporting documents to the ward office of their area. Our staff will visit the house for verification. A licence will be issued after due procedure. So far, we have received 300 applications, of which, we have issued 150 licences," he informed. (PTI)

## Gujarat AAP MLA Chaitar Vasava arrested on attempt to murder charges

RAJPIPLA (GUJARAT), JULY 6 --/ Gujarat AAP MLA Chaitar Vasava has been arrested on charges of attempt to murder after he allegedly attacked a talukapanchayat functionary at Dediapada in Narmada district, police said on Sunday. The incident took place on Saturday during a meeting organised at the prant office under Vasava's constituency Dediapada. Vasava was arrested late Saturday night, the police said. During the meeting, Vasava got agitated after raising objection over his nominee not being considered for appointment as a member of the 'AapnoTaluko Vibrant Taluko' (ATVT), a local-level coordination committee, as per the FIR registered at Dediapada police station.

Vasava allegedly started abusing a woman president of Sagbaratalukapanchayat. When Dediapataluka panchayat president Sanjay Vasava, who was part of the meeting, objected, the MLA allegedly attacked him by hurling a mobile phone at him, causing injuries on his head, according to the complaint lodged by Sanjay Vasava. The legislator also tried to attack the complainant with a glass but was prevented from doing so by police

personnel present there, as per the FIR. However, as the glass broke, the MLA picked up the glass shards and approached towards



Sanjay Vasava and threatened to kill him.

The complainant somehow managed to escape, it said. The MLA damaged a chair kept in the office, the complaint alleged. An FIR was subsequently registered at Dediapada police station under

sections 109 (attempt to murder), 79 (insulting the modesty of a woman through words, gestures), 115 (2) (voluntarily causing hurt), 351 (3) (criminal intimidation), 352 (intentional insult) and 324 (3) (damage to property) of the BharatiyaNyayaSanhita. Meanwhile, as tension escalated in Dediapada following Chaitar Vasava's arrest, the local administration imposed restrictions on the gathering of more than four persons at one place in the area, to maintain law and order.

AamAadmi Party's national convener Arvind Kejriwal claimed the MLA was arrested as the BJP was "furious" after losing to AAP in Visavadar, referring to the recent bypoll in which his party candidate Gopal Italia won. "AAP MLA @Chaitar\_Vasava has been arrested by BJP in Gujarat. BJP is furious after losing to AAP in the Visavadar by-election. If they think that AAP will be scared by such arrests, then this is their biggest mistake. People of Gujarat are now fed up with BJP's misrule, BJP's hooliganism and dictatorship, now the people of Gujarat will answer BJP," Kejriwal charged in a post on X. (PTI)

## NATGRID asks states to use its database to control criminal activities

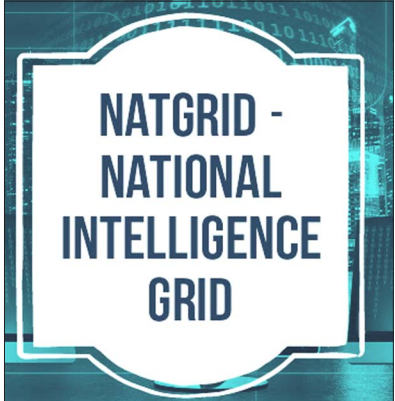
NEW DELHI, JULY 6 --/ The NATGRID, which shares real-time information for intelligence services and investigations with law-enforcement agencies, has asked all state police forces to enhance their engagements with it and proactively use its database for crime control and checking criminal activities. The NATGRID, which comes under the direct control of the Ministry of Home Affairs (MHA), shares with 11 central agencies and all state police forces real-time information from its database on terror activities, organised criminal gangs, financial transactions, immigration, circulation of counterfeit currency and narcotics, besides other inputs.

In a letter to the police chiefs of all states, PiyushGoyal, Chief Executive Officer of the NATGRID, has requested them to enhance the usage in their respective forces to increase the number of active users and encourage them to effectively utilise the NATGRID solution. The letter specifically emphasised on encouraging the district superintendents of police (SPs) for a wider use of the NATGRID database in their crime-control and law-enforcement initiatives.

"This may please be reviewed in your meetings periodically. NATGRID is continuing to augment more features/functionality in the solution and conducting regular training/feedback sessions," Goyal said in the letter. He said the NATGRID can additionally organise dedicated

training sessions for police officers, wherever required. The letter said with collaborative efforts, many new users have started using the system proactively and there has been a significant increase in the usage of NATGRID solution.

"I would like to highlight and commend the consistent usage of



NATGRID solution by Andhra Pradesh, Haryana, Rajasthan, Maharashtra and Assam, which are the top performers for the period Jan-Jun 2025," Goyal said in the letter. Besides these states, he also appreciated the efforts made by Tamil Nadu, which enhanced "the number of active users who have fired at least one query in a month" by four times in June, with the resultant significant increase in their usage of the system as well. Conceptualised after the 26/11 Mumbai terror

attacks, the NATGRID disseminates information to agencies like the IB, R&AW, CBI, Central Board of Direct Taxes (CBDT), Directorate of Revenue Intelligence (DRI) and Enforcement Directorate, besides others. It has a database of more than 20 categories like railways, banks, airlines, credit-card companies and immigration. The work on the National Intelligence Grid (NATGRID) was accelerated after Amit Shah became the Union home minister in 2019, officials said. The necessity for the NATGRID came after the worst terror attack in India's history in the country's commercial capital in 2008 exposed the deficiency that security agencies had no mechanism to look for vital information on real time.

The lack of real-time information was considered to be one of the major hurdles in detecting US terror suspect David Headley's movement across the country during his multiple visits between 2006 and 2009. Headley provided key information and videos of terror targets to Pakistan-based Lashkar-e-Taiba (LeT), which carried out the 26/11 Mumbai attacks that claimed 166 lives. The Cabinet Committee on Security (CCS) had given its approval to the Rs 3,400 crore project on April 8, 2010 but its work slowed down after 2012. However, Prime Minister Narendra Modi has realised the importance of the key security project and directed its revival, the officials said. (PTI)

## Dinesh Lal Yadav 'Nirahua' dares Thackeray cousins to drive him out for speaking Bhojpuri

MUMBAI, JULY 6 --/ With MNS resorting to street-fighting over Marathi, actor and singer Dinesh Lal Yadav, popularly known as Nirahua, has dared the Thackeray cousins to drive him out of Maharashtra for speaking in Bhojpuri. Hitting back, an MNS leader said Yadav should visit Maharashtra if he has guts. Yadav had unsuccessfully contested the 2024 elections from Azamgarh Lok Sabha constituency against Samajwadi Party's Dharmendra Yadav.

"I am giving an open challenge. I do not speak Marathi. I speak Bhojpuri, and I am

staying in Maharashtra. Why are you driving poor people out? If you have the courage then drive me out. I am giving you a challenge, even in Mumbai," Yadav told reporters. He alleged dirty politics behind attempts to create a rift among people over language. "The beauty of the country is the diversity of languages and people speaking different mother tongues are living amicably. You want to destroy this beauty," he added. Amid allegations of the state government "imposing" Hindi language in Maharashtra, MNS workers thrashed a shopkeeper near Mumbai for not speaking Marathi. On Saturday, the glass door of the office of share market investor SushilKedia was vandalised after he declared he wouldn't

speak Marathi. Days after the government withdrew its orders on introducing Hindi as a third language in primary schools, MNS president Raj Thackeray and his cousin Uddhav Thackeray held a "victory" rally on July 5 and reunited after 20 years. Maharashtra NavnirmanSena (MNS) leader YashwantKilledar dared Yadav to visit Maharashtra instead of making such remarks by sitting in Uttar Pradesh. He will know about his challenge, and MNS workers will hit his cheeks, Killedar said.

Rattled by the unity of the Marathi mannos, the BJP is propping up such people who are sponsored by the government, he alleged. Shiv Sena (UBT)

leader and former mayor KishoriPednekar said no one wants to resort to violence and that both leaders (Uddhav and Raj) have explained their position.

"Should we fold our hands before them (who make such comments)?" she asked. (PTI)
